Crack in slider noted by Bob after 10/31/25. 10/23/25 she met with FEMA—FEMA rep said plumbing okay, electric, kitchen, etc was fine, so advised her to use alt bedroom & DR for storage, she slept in main BR—she has photos of water stains in main BR—FEMA told her she could move

in. Clearwater set up separate hurricane permits so she was able to move in by Nov. 11 with everything according to the law.

Shawn Chase from Unit 61 Flooding: Bob at Dunedin Plumbing Sunday June 15—came Monday June 16. Described extensive destruction—hot and cold water pipes broken inside slab. Owner talked to Sawyer and Jim at Dunedin Plumbing. \$350 charge for leak detection when it wasn't working. Charlie is owner of Dunedin Plumbing.
